



VERITAS CERTIFICATION EXAMINATION AND TRADEMARK USE AGREEMENT

THIS VERITAS CERTIFICATION EXAMINATION AND TRADEMARK USE AGREEMENT IS AN AGREEMENT BETWEEN VERITAS TECHNOLOGIES LLC AND/OR ITS SUBSIDIARIES (“VERITAS”) AND THE INDIVIDUAL EXAMINEE (“YOU”).
