Veritas Technologies, and its group of companies ("Veritas", "our" "us" "we") is committed to respecting your personal information ("Information") and providing transparency around how it is used in accordance with applicable privacy laws. PERSONAL INFORMATION WE COLLECT VIA OUR WEBSITES AND EVENTS

Our websites allow you to interact with us in different ways, such as managing your account, registering for and attending our events, and enabling you to learn about our products and services.

To manage the different aspects of our relationship with you we may collect:

- Your contact details including name, mailing address, email address and phone number;
- Shipping, billing and payment details;
- Information necessary to deliver customer service or technical support;
- Device information, browser type and settings, IP address and traffic data relating to your Internet connection;
- Veritas product performance data and information about how you use our products and services on our websites;
 and
- Website analytics data created by your use of our websites.

Collectively we call the personal data you provide during your interactions with us as "Your Information".

HOW WE USE YOUR INFORMATION

We may use Your Information to:

- Manage your MyVeritas account, your transaction history, entitlement to products, services, and events;
- Provide you upon request with commercial quotes for our products and services;
- Manage your purchase transactions and provide you with customer and technical support;
- Send you product information, technical alerts, updates, promotions or offers applicable to our business;
- Manage your participation in events that you have registered for with us or those organized by third parties on our behalf and capture your interests in related products, services and events;
- Analyze and improve the quality of our websites, products and services;
- Enable interoperability within our applications; and
- Enforce our legal rights, conduct usage audits or comply with legal requirements.



Marketing

Based on Your Information and communication preferences we may send you marketing information about Veritas products, services and events, including sending you related advertisements from our trusted third parties. Where we provide you with interest-based advertisements on a site other than our own, we do not track your other activities on that site. If you click on our advertisements, we will know only the domain you came from.

You can manage your communication preferences on the webpages and forms on which we collect Your Information and through your MyVeritas account. You can opt-out of our marketing emails by clicking the unsubscribe link within the message body or by going to our Email Preference Page. You can also contact us using the details in the **Contact Us** section below.

Information From Third Parties

As part of lead generation we may also use legally acquired data sets from third parties, distributors, channel partners, event organizers and agencies. We may combine this with Your Information to improve the quality of our offerings to you and your overall experience with us.

Veritas Website Forums

We operate online forums on our websites to assist you in using our products, services and events and to allow you to discuss technical issues and share your experiences. Any information that you provide in these public forums is not confidential and may be read, collected and used by other Forum users. THE LEGAL BASIS ON WHICH WE RELY TO PROCESS YOUR INFORMATION

Privacy laws oblige us to explain the legal basis for collecting and processing Your Information. Depending upon the specific context in which we collect it, our legal basis for processing will be one or more of the following:

- Where we have your consent; or
- Where the processing is in our legitimate interests; or
- Where the processing is necessary for compliance with a legal obligation.

TRANSFERS OF YOUR INFORMATION

We are a global company and may store and process Your Information in any country where we have facilities or in which we engage service providers to deliver our products, services and events.

Transfers of Your Information outside of the original country of origin will only occur when we are satisfied that the transfer destination provides an adequate level of protection for personal information and/or appropriate safeguards are in place to protect it. Where a transfer destination is not deemed to have adequate protection for personal information, we will use appropriate safeguards in order to protect that information including the use of Standard Contractual Clauses for transfers outside of the European Economic Area ("EEA") and the IDTA for transfers outside of the United Kingdom.

COOKIES & DO-NOT-TRACK

Cookies

A cookie is a commonly used automated data collection tool. Cookies are small text files that are placed on your computer or device by websites that you visit or HTML-formatted emails you open, in order to make websites work, or work more efficiently.

We may use cookies, Web beacons, pixel tags or other similar technologies on our websites or emails to:

- Tailor information presented to you based on your browsing preferences, such as language and geographical region;
- Collect statistics regarding your website usage;



- Provide us with business and marketing information; and
- In some cases, to enable a third party to deliver future advertising for our products and services to you when you visit certain websites owned by third parties.

We use different kinds of cookies:

- **Essential cookies** are necessary to provide you with certain services and features available through our websites. Without these cookies, services you may need, such as shopping carts or e- billing, cannot be provided.
- Analytics or customization cookies collect information that is either used in aggregate form to help us understand how our website is being used or how effective our marketing campaigns are. They also help us customize the website for you.
- Advertising cookies and tracking scripts are used to make advertising messages more relevant to you. They
 perform functions like preventing the same ad from continuously reappearing, ensuring that advertisements are
 properly delivered and, in some cases, featuring advertisements based on your interests.

If you do not wish to receive cookies you may be able to configure your browser or device settings to reject cookies. If you do so, we may be unable to offer you some of our functionalities, services or support. If you have previously visited our websites, you may also have to delete any existing cookies from your browser.

Do-Not-Track

There are different ways you can prevent tracking of your online activity. One of them is setting a preference in your browser that alerts websites you visit that you do not want them to collect certain information about you.

Third Party Data Collection

This may include cookies placed by third parties that deliver tailored information and content which may be of interest to you, such as promotions or offerings, when you visit third party websites after you have left our websites.

Social Media Features and Widgets

Our websites may include social media features, such as Facebook's "Like" button, and widgets, such as the "Share This" button, or interactive mini-programs that run on our site. These features are usually recognizable by their third-party brand or logo and may collect your IP address, which page you are visiting on our site, and set a cookie to enable the feature to work properly. Social media features and widgets are either hosted by a third party or hosted directly on our site. Your interactions with these features are governed by the Privacy Notice of the company providing it.

HOW WE SHARE YOUR INFORMATION

We do not sell, rent, lease, release, disclose, disseminate or otherwise make available to another business or third party, Your Information, for purposes other than those needed to provide our products and services and in accordance with the "How We Use Your Information" Section above. We share Your Information as follows:

Partners

We may provide Your Information to our certified partners – those authorized to promote and sell our products and services - for the sole purpose of allowing them to conduct Veritas business. Subject to legal requirements, these partners may use Your Information to communicate with you about Veritas products or services that they believe are of interest to you or your business.

If you do not wish to receive promotional emails from our partners, you can unsubscribe directly in the footer of the partner's email to you or via the **Contact Us** section below.

Service Providers Processing Data On Our Behalf

We may use contractors and service providers to process Your Information on our behalf for the purposes described in this Privacy Notice. These recipients include outsourced IT services, marketing agencies, temporary staff, analytics providers, and outsourced order processing.

We contractually enforce that contractors and service providers keep information secure and confidential. We do not allow them to share or use Your Information without our prior authorization. Where you have an independent relationship with these service providers their privacy notices will apply.



Events, Sponsors & Partners

If you attend an event or webinar organized by us, or download or access any material on our website, we may share Your Information with the sponsors and partners of that event where you have provided consent for us to do so. You can optout in accordance with this Privacy Notice.

Where you provide your details at an event for example by allowing your attendee badge to be scanned at a sponsor booth, your information will be subject to that particular event privacy notice. If you do not wish for your information to be shared, you may choose to not opt-in via event/webinar registration or not provide your Information at the event.

Law Enforcement

In certain instances, and under applicable law, it may be necessary for us to disclose Your Information to government officials or other third parties in response to the following:

- A subpoena, warrant or other process issued by a court of competent jurisdiction;
- A legal process having the same consequence as a court-issued request for information, in that if we were to refuse
 to provide such information, it would be in breach of local law, and it or its officers, executives or employees would
 be subject to liability for failing to honor such legal process;
- Where such disclosure is necessary for us to enforce our legal rights pursuant to the laws of the jurisdiction from which such information was gathered, or where we reasonably consider that this is necessary for it to protect our legal rights or to allow a third party to do so;
- A request for information with the purpose of identifying and/or preventing financial fraud; or
- Where such disclosure is necessary to prevent or lessen a serious and imminent threat of bodily harm to an individual.

Transfer Among Veritas Entities

We are a global company headquartered in the United States. To enable us to conduct our business Your Information may be transferred to our subsidiaries and third parties in Europe, the Middle East, Africa and Asia Pacific. All transfers will occur in compliance with the data transfer requirements of applicable laws and regulations and in accordance with this Privacy Notice.

Business Transfers

In the course of operating our business, we may choose to buy or sell certain assets. As a result of these transactions, customer information is usually one of the business assets that is transferred. Conversely if we were acquired or a substantial portion of our assets were sold, or if we were to go out of business, enter bankruptcy proceedings or experience some other change in control, Your Information may be part of the assets which are acquired by or transferred to a third party. If appropriate we may take reasonable steps to notify you of any such deal and outline your choices in that situation.

Professional Advisers

We may need to share Your Information where it is necessary to obtain advice on legal, financial or other regulatory matters.

HOW WE STORE, RETAIN & PROTECT YOUR INFORMATION

Your Information may be stored on servers anywhere Veritas or our vendors operate. Your Information will be held for as long as is necessary for the purpose for which we collect it, including for the provision of service, billing and administration, and to comply with our legal obligations, resolve disputes and enforce our agreements, after which it will be deleted or anonymized for statistical purposes.

We use appropriate technical and organizational measures to protect Your Information from misuse, unauthorized, accidental or unlawful access or disclosure, loss, alteration, damage or destruction. These measures include but are not limited to, organizational, physical and technological safeguards such as processing data within secure facilities, utilizing end point protection and encryption tools whilst ensuring our employees undergo mandatory privacy and security training.

Links to Other Websites

Our websites may contain links to other websites, which are owned or operated by other companies. We are not responsible for the content or privacy practices of websites that are owned by companies that are not within the Veritas



group of companies and we encourage you to review their privacy notices accordingly.

Our websites may also link to co-branded websites that are maintained by Veritas and one or more of our business partners. To understand how Your Information is used by these sites please refer to the applicable privacy notice.

Children's Privacy

Our site is not directed to, nor do we knowingly collect information from, children under the age of 13.

YOUR DATA RIGHTS

Accessing, Deleting, Updating or Correcting Your Information

You can manage Your Information via your MyVeritas account and can ask us for a copy of Your Information, and/or request us to correct it, erase it or to transfer it to other organizations. You have the right to object to processing such as automated decision making and profiling. Where we have asked for your consent to process Your Information, you may withdraw this consent at any time.

Where we process Your Information because we have a legitimate interest in doing so you have the right to object to this. You may also have the right to restrict processing of Your Information. These rights may be limited in some situations – for example, where we can demonstrate that we have a legal requirement to process Your Information. Right to opt out of the sale or sharing of Your Information
